Minutes from the October Board Meeting were approved as printed in Smoke Signals.

Treasurer's Report: Checking; \$1,541.76 – Savings; \$1,691.03

<u>Membership Report</u>: Several membership renewals for 2011 have been received, as have a few reservations for the holiday dinner. No change in total club membership numbers.

Events: The La Palma Days parade is Sunday, November 13 and additional ARO communicators are still needed. Contact Larry Tishaure at <ltichauer@sbcglobal,net> if you can help. Antennas in the Park will be held this coming Saturday (11/6/10) at Tri-City Park in Placentia. The Club holiday and officer installation banquet is scheduled for Friday, December 17. Bill Kohlenberger W6ZJE and Bill Preston KZ3G are developing plans for the next Ham license class; probably at the Technician level, with consideration of extension to General class. Dates and location are yet to be determined,

There was a brief discussion as to whether members would like to have shirts with the Club logo and member name and call. It was noted that many members would prefer a shirt with their own call. Type of shirt and cost is to be determined through inquiries by Albert Solomon and Paul Broden.

The Tuesday night Club Net has is currently non-functional, in part due to problems with the repeater. Consideration of a simplex frequency or alternate repeater use remains in discussion.

New Business: Field Day results are now published on the ARRL web site. FRC ranks 7<sup>th</sup> in the nation and only station in the ORG section for 2A Commercial [commercial power] classification with 1854 points. The HDSCS station ranked 1<sup>st</sup> for 2A for the ORG section with 3050 points out of a total of 472 2A stations. Field day 2010 had a total of 37,965 participants (not stations), with a total of 1,329,810 points, which is a decline from 2009.

The Board will be considering two suggestions for inclusion in Smoke Signals; one to include computer links that may be valuable to members; and the other to include classified ads.

## Solar Cycle 24? What's up?

An international Prediction Panel of scientists meeting Oct 2-6, 2006, collaborated to estimate expectations for the up coming 24th solar cycle. New predictive techniques developed after cycle 23 peaked in 1997 were used at the meeting. So, the plot of Cycle 23 spot count & radio output was published with two different follow-on model estimates for cycle 24. See Figure 1, or from NOAA/NASA on-line at <a href="http://www.swpc.noaa.gov/SolarCycle/">http://www.swpc.noaa.gov/SolarCycle/</a>.

By Sept. 2010, lower count and cooler flux data, is even below the lower model curve estimates. What's the sun doing? The spot count & radio output plots of recent data and estimate show the difference today.


While VHF/UHF bands rarely change, HF thru 6 meter-DXers are seeing a few band openings during this lower solar activity. Yet, during Saturday's Ants-ITP, Dick, WB6JDH had a number of QRP contacts on 15 meters. Still, Cy-24 seems slow to grow.


Beyond close ham radio interest, lower solar output affects on possible climate cooling is welcome but doesn't verify "global warming". For "SKYWARN" hams, " a news letter, "Coast to Cactus Weather Examiner", Vol 17 #4 in PDF, was E-mailed by the National Weather Service Office, San Diego.



## **QST QST QST - TO ALL HAMS**

Last month Smoke Signals published an article entitled "Amateur Radio – mobile use" referring to a New York judge who declared that amateur radio is not a cell phone, and use of mobile radios is not subject to traffic tickets as is the use of cell phones. Well, read on; the problem continues elsewhere. See the following article from ARRL Orange Section.

A local ham has received a ticket for NOT using a hands-free device while talking on his Amateur Radio. The officer really did not care to hear his story that this is not a cell phone.

Please take heed: DO NOT argue with the officer. Please DO NOT wave a paper in front of their face to prove that you are not using a wireless cell phone. The officer will stop you and it is already set in his/her mind that you will be receiving a ticket.

Some officers may understand, but you are using a push to talk device, which takes your hand of the wheel.

This is what was noted about the device he was using was on this hams ticket "Non-hands Free".

Do this: Instead, document the conversation, accept the ticket, and develop a case for the traffic court date.

Here is the California Code California vc 23123 is as follows: Interpretation is tough but maybe 23123(e) is our only hope.

V C Section 23123 Hand Held Wireless Telephone Prohibited Use Hand-Held Wireless Telephone: Prohibited Use 23123. (a) A person shall not drive a motor vehicle while using a wireless telephone unless that telephone is specifically designed and configured to allow hands-free listening and talking, and is used in that manner while driving. (b) A violation of this section is an infraction punishable by a base fine of twenty dollars (\$20) for a first offense and fifty dollars (\$50) for each subsequent offense. (c) This section does not apply to a person using a wireless telephone for emergency purposes, including, but not limited to, an emergency call to a law enforcement agency, health care provider, fire department, or other emergency services agency or entity. (d) This section does not apply to an emergency services professional using a wireless telephone while operating an authorized emergency vehicle, as defined in Section 165, in the course and scope of his or her duties. (e) This section does not apply to a person when using a digital two-way radio that utilizes a wireless telephone that operates by depressing a push-to-talk feature and does not require immediate proximity to the ear of the user, and the person is driving one of the following vehicles:

- (1) (A) A motor truck, as defined in Section 410, or a truck tractor, as defined in Section 655, that requires either a commercial class A or class B driver's license to operate. (B) The exemption under subparagraph (A) does not apply to a person driving a pickup truck, as defined in Section 471.
- (2) An implement of husbandry that is listed or described in Chapter 1 (commencing with Section 36000) of Division 16.
- (3) A farm vehicle that is exempt from registration and displays an identification plate as specified in Section 5014 and is listed in Section 36101.
- (4) A commercial vehicle, as defined in Section 260, that is registered to a farmer and driven by the farmer or an employee of the farmer, and is used in conducting

commercial agricultural operations, including, but not limited to, transporting agricultural products, farm machinery, or farm supplies to, or from, a farm.

- (5) A tow truck, as defined in Section 615.
- (f) This section does not apply to a person driving a schoolbus or transit vehicle that is subject to Section 23125.
- (g) This section does not apply to a person while driving a motor vehicle on private property.
- (h) This section shall become operative on July 1, 2008, and shall remain in effect only until July 1, 2011, and, as of July 1, 2011, is repealed.

Added and repealed Sec. 4, Ch. 290, Stats. 2006. Effective January 1, 2007. Operative July 1, 2008. Repeal operative July 1, 2011. Amended Sec. 2, Ch. 214, Stats. 2007. Effective January 1, Operative July 1, 2008

NOTE: The preceding section is repealed January 1, 2011, at which time the following section becomes operative.

- 23123 (a) A person shall not drive a motor vehicle while using a wireless telephone unless that telephone is specifically designed and configured to allow hands-free listening and talking, and is used in that manner while driving. (b) A violation of this section is an infraction punishable by a base fine of twenty dollars (\$20) for a first offense and fifty dollars (\$50) for each subsequent offense.
- (c) This section does not apply to a person using a wireless telephone for emergency purposes, including, but not limited to, an emergency call to a law enforcement agency, health care provider, fire department, or other emergency services agency or entity. (d) This section does not apply to an emergency services professional using a wireless telephone while operating an authorized emergency vehicle, as defined in Section 165, in the course and scope of his or her duties.
- (e) This section does not apply to a person driving a schoolbus or transit vehicle that is subject to Section 23125.
- (f) This section does not apply to a person while driving a motor vehicle on private property.
- (g) This section shall become operative on July 1, 2011. Added Sec. 5, Ch. 290, Stats. 2006. Effective January 1, 2007. Operative July 1, 2011. Amended Sec. 3, Ch. 214, Stats. 2007. Effective January 1, 2008. Operative July 1, 2011

The ARRL printed an article regarding an amateur who received a ticket and the Judge ultimately released the charge stating that his device was not a wireless telephone because it is not part of a phone company or other entity that controls the wireless telephone and put his device in with a CB.

We need a good interpretation of our vc 23123 to determine where Amateur Radio falls. There was a letter that circulated in 2008, but what does the DMV and CHP think now!

A Note: Tickets are being given out more frequent now for distractions: eating, drinking, reading, just plain not paying attention while driving.

Be careful out there use a hands-free device such as a headset with mike attached (single ear only).
