August Meeting Presentation

Dennis Kidder W6DQ will be our featured presenter for the August meeting. Dennis will cover the history of Voice of America at the Delano, California site. Dennis will also be discussing recovery of Collins 821A shortwave broadcast transmitter from the site, now located at the AWA museum in Bloomfield, NY. Below is an article for you to read in advance of Dennis' presentation, with some of the history details.

Saving a piece of shortwave history - Dennis Kidder W6DQ

I may be a bit biased but this had to be one of those great moments that many of us dream of -- being part of a team performing some radio "archaeology" and recovering a significant piece of the history of the Collins Radio Company and preventing it from being turned into scrap. I am speaking of a Collins 821A-1 shortwave broadcast transmitter, one of three that were located at the Voice of America's Delano Relay site, here in California's Central Valley. Collins manufactured and installed nine of these transmitters, the largest shortwave transmitter they ever produced, weighing in at a "cool" 22 tons and producing 250 KW of carrier power. Do the math ... that's one megawatt peak output power!

The Collins Collectors Association (CCA) was tasked with removing this transmitter from the Delano site and placing it into storage so that it may eventually be put on display at the Antique Wireless Association (AWA) Museum in Bloomfield, New York. The Collins Collectors Association, in association with the AWA, have formed a cooperative alliance known as the Collins Radio Heritage Group (CRHG) whose mission is to preserve "and display the anecdotal heritage of the Collins Radio Company." As a member of the Board of Directors of the Collins Collectors Association, I was suddenly thrust into the project, and as those of you who know me, rather than kicking and screaming, I jumped in headlong!

The road to this end has been a long one. It began when the International Broadcasting Bureau (IBB) ceased operations at the Delano facility in October of 2007. Created in 1994 as part of the United States Information Agency (USIA), IBB became the operator of VOA. VOA operations had been under USIA since it began operations in 1953. In 1999 the USIA was disbanded and IBB became an independent federal government entity. Delano Relay, as the name implies, was used to relay broadcasts from Washington, D.C. on to other USIA transmitting sites located in the Philippines and Africa. More recently, VOA Delano supported Radio Marti, targeting Cuba and also carried program material for the British Broadcasting Company. Newer technologies such as satellite communications along with the increasing scarcity of replacement parts for the site's nine transmitters eventually led to the shutdown.

Following the shutdown, IBB transferred ownership of the facility to the Government Services Administration (GSA) who was tasked with disposal of the site. Several years ago an effort led by Mike Dourrough, KO6NM, a very notable broadcast engineer, was mounted to try to save the site and turn it into a museum. Unfortunately, the high asking price by GSA for the property all but shutdown his efforts.

After years of seeking to dispose of the site, GSA was approached with a plan to remove and preserve one of the Collins transmitters in a museum setting. This plan had the backing and support of Rockwell Collins, the Collins family and the newly formed alliance between CCA and AWA, CRHG. After a year of bureaucratic roadblocks and red tape, ownership of the transmitter, "DL-8" and other associated "paraphernalia," was transferred to the CRHG. There was one catch ... we had two weeks to get the 22 tons of gear off of the site.

The extraction team was assembled and we descended on Delano to get to work. The team consisted of Bill Carns, N7OTQ, President of the CCA, Jim Stitzinger, WA3CEX, former board member and secretary of the CCA and Jim's helper, Tim Zeichik, Scott Kerr, KE1RR, Vice President of the CCA, Rod Blocksome, N0DAS, former Collins engineer, Brian Gieryk, KE6IYC, Dave Jennings, WJ6W, Joe Knight, representing the AWA, and myself, Dennis Kidder, W6DQ, Board Member and Secretary of the CCA. Our task was a daunting one ... disassemble 22 tons of

transmitter and prepare it for transport, documenting every piece so that we may reassemble it down the road. There were a LOT of pieces.

To give you an idea of what was involved, one of my tasks was to disconnect the wiring harnesses from the control room to the transmitter. This would seem a pretty simple task. But when you consider that there were 1600 wiring tie points just to the "diagnostic panel" of the transmitter, this isn't so simple.

In the end, we all realized that the transmitter would never take to the airwaves again and a decision was made that in order to expedite the removal we would cut the cables behind the racks rather than trying to preserve the wiring harnesses intact. I must tell you that cutting through that first cable was a very emotional moment for me. The cables were cut such that when the transmitter goes back on display, they cuts are concealed by the valence panels of the transmitter racks.

We did manage to extract the transmitter and have it loaded out and on the road within the allotted timeframe. We even finished a bit early, giving us some time to do a little "sightseeing" on the property. There is nothing quite like standing at the base of a 400 foot tall dipole curtain array! That is a very large antenna. In addition to the five dipole curtains, there are six large curtain rhombics. Four are each installed on four 150 foot towers. The other two, also using the 150 foot towers, are so large that there are four additional towers at the center of each span. There is *nothing* small at the VOA Delano Relay site.

I mentioned at the beginning that the project included some radio "archaeology." When the site was shutdown and abandoned in 2007, it was as if everyone packed their bags and walked out the door, leaving behind a treasure trove of VOA and USIA memorabilia. When we had time to take breaks from the tasks at hand, we found ourselves exploring the environs of the transmitter building and several outlying structures. There were two goals in doing this. First, we had to locate some of the specialized "tooling" to accompany the transmitter to the museum. This included custom winch assemblies to remove the PA and modulator tubes, as they each weigh nearly 100 pounds. One of the notable bits of history that we found in the flotsam was a pile of unanswered reception reports and QSL card requests! And of course we found a few blank QSL cards as well. This material was handed off to the AWA with the hope that those QSL requests may finally be fulfilled. Other pieces of history from the site will eventually be placed on display at AWA.

But the project doesn't end here. We are at the halfway point, so to speak. Over the next two years we will be continuing to raise funds to support the placement of the mighty 821A-1 at the AWA Museum. And for me personally, it will mean that I get to get my hands dirty again. We will attempt to reconvene our team to restore and reassemble the 821A-1 at the museum. Something I am very much looking forward to doing. Stay tuned ... there will be an upcoming talk at FRC!

ARDF Team USA 2014 has formed

USA's Amateur Radio Direction Finding (ARDF) Team for 2014 has formed and is in training for the Seventeenth ARDF World Championships, September 6 through 13, 2014 near Burabay, Kazakhstan. "Training camps" in three states are helping them get ready with one or more challenging allon-foot radio-orienteering events every day.

First, the Backwoods Orienteering Club (BOK) sponsored the Birkhead International ARDF Competition and Training Camp near Asheboro, North Carolina for seven days beginning July 17. Then on the weekend of July 19-20, west coast ARDF fans gathered at Mt. Pinos near Frazier Park, California for three competitions plus a barbecue cookout. Another weekend session of ARDF at Mt. Pinos takes place August 16-17, with results and photos posted in the "Homing In" Web site (www.homingin.com/park). Finally, during the last week of August, Vadim Afonkin KB1RLI will set training courses in the Boston area.

Because of their performances in the USA ARDF Championships in North Carolina (2013) and Massachusetts (2014), twenty radio-orienteers were given invitations to join ARDF Team USA 2014. For various reasons, twelve of them are not able to go. The team now includes five men and three women, ranging in age from 29 to 72, plus one member of the international jury. Two years ago, the thirteen members

of Team USA brought home thirteen medals from the World Championships in Serbia. I look forward to reporting on the team's performance in this year's World Championships in an upcoming issue of Smoke Signals.
